#### Notes:

Following this plan will allow you to complete your Bachelor of Science in Business Administration (B.S.B.A.) with a major in International Business and the required minor in Business in four years (eight semesters), assuming you meet minimum performance expectations in all courses. Give careful attention to course prerequisites, as they are strictly enforced. If you choose to earn your degree over a period longer than four years, the basic sequence of courses shown above will still apply in most cases. If you decide to deviate from the recommended sequence, you should consult with the College of Business Advising Center for assistance in developing an alternative plan.

<sup>1</sup>The Bachelor of Science in Business Administration (B.S.B.A.) with a major in International Business is a selective admission program. Students enter the program as a Pre-International Business major. Upon completion of the six courses in the selective admission group (ACC 200, ACC 201, BUS 230, ECO 200, ECO 201, and MKT 205) with a grade

of C- or better in each and the achievement of an overall NKU GPA of 2.500 or better, students are officially admitted to the college as a BSBA-International Business major. All transfer students enter as pre-majors and must complete a minimum of 12 credit hours at NKU in order to establish the NKU GPA for selective admission into the major, regardless of individual course completion status.

<sup>2</sup>BUS 260 and BUS 360 designate credits for the required 3 credit international experience. Typically, there are opportunities for qualified study abroad experiences available in fall, spring, and summer. Most experiences will offer the opportunity to earn course credit that can also be used to fill other course requirements in the major. The third year is the typical time to fulfill this requirement, but it may be fulfilled at any time during the degree program. Early planning with the Director of International Business is imperative to chart the most efficient path through the major.

<sup>3</sup>This major requires you to demonstrate an ACTFL ranking of Intermediate-Mid in a second language. More details are furnished in the university catalog and from your advisor and the Director of International Business. It's possible to meet this requirement without taking foreign language courses at NKU; however, those with little prior preparation should consider using one or more language courses taught in the Department of World Languages and Literatures to meet the Culture and Creativity category Foundation of Knowledge requirement.
